## June 21, 2000 Meeting Summary

The meeting was held at the Cape Fear Country Club and featured David Sousa, JD, Senior Vice President and General Counsel for Medical Mutual Insurance Co. of N.C. (MMIC-NC) who spoke about asset protection from excessive malpractice verdicts. In his talk he stated that one of ten MMIC insured physicians will be the target of a law suit annually. The average award over the past three years has been \$300,000. For awards greater than \$500,000, the average has been \$3.5 million per case. Jury awards continue to climb in N.C., a state with a previously lower rate of malpractice awards. A copy of a summary of recommendations can be obtained from the NHPCMS office or through Medical

### N.C. Medical Society News

The **OPA (Operation Physician** Advocacy) Meeting, which NCMS is holding here, will be Tuesday, August 22nd. All physicians, whether or not they are local or state members, are invited to attend, have a light meal, and voice their ideas and concerns to State staff. The venue is the Hilton Riverside, 6 PM. Program begins at 6:30 PM and ends no later than 8:30 PM . New Hanover - Pender had one of the largest turnouts in the state for the last OPA meeting here! ## **Managed Care**

In May and June we were made aware of the importance of a N.C. bill to be considered at the most recent legislative session in July regarding the following facts:

- There is NO STANDARD in North Carolina law for the timely processing of health claims.
- There is no enforcement mechanism or effective remedy for consumers, hospitals or physicians when health plans delay payment.
- There is NO INFORMATION available to regulators about the prompt processing of claims.
- There is NO DISCLOSURE of the problems a health plan identifies with a claim. The bill should be amended to assure physicians are told at the outset about problems with their claims.
- The bill adopts a widely used business standard for the payment of business obligations (30 days, 18% interest per year on unpaid claims).

Through grass roots efforts on the part of the N.C. Medical Society and N.C. physicians the bill was successfully passed on July 14, 00. This represents a true milestone in the ongoing struggle for physicians to have recourse regarding the rampant non-payment and late payment of medical claims by third party payors. VICTORY! Prompt Pay Gets Final Approval

In the last hours of the 2000 legislative session Thursday evening, lawmakers put their final stamp of approval on the NCMS proposal for prompt payment of health insurance claims. The unanimous vote marked a victory in the laborious two-year project headed up by the NCMS and the NC Academy of Family Physicians. Thanks to the tireless efforts of physicians all across North Carolina, our legislative team had the necessary support to pass this much-needed legislation this summer. Your phone calls, emails, letters, and personal visits with legislators were crucial to our success in Raleigh. In a strategic effort to ensure passage of prompt pay language, NCMS advocates identified and amended a healthrelated bill on the fast track in the Senate, H1340 Respiratory Care Practice Act, to include our proposal. This placed the prompt pay measure in two vehicles, positioning the NCMS with several options in the final days of the session. Speaker James B. Black (D-Mecklenburg) placed H1340 on the calendar for consideration Thursday resulting in a 98-0 final vote.

#### Prompt Pay Highlights:

- Requires health plans to pay claims or fully disclose claim problems within 30 days.
- Gives health plans one opportunity to notify providers of deficiencies in a claim.
- Imposes interest at the rate of 18% for failure to pay claims within the specified period.

4. Authorizes the Insurance Commissioner to impose fines for non-compliance

The NCMS will provide a detailed analysis of this and other bills affecting the practice of medicine in the 2000 Legislative Summary. The Summary should be available on the NCMS website within the next few weeks. Congratulations to everyone on a successful team effort!!
