#### The Cure for the Bad Week Blues

As I was packing up my bags to move my family from Charlotte, NC to Wilmington, I was told by

many people what a strong medical community I was moving into. As a newcomer to the area and a young physician, I didn't really understand what that meant. However, in the little over 3 years that I have been in Wilmington, I have found that statement to be true and, possibly, an understatement.

Shortly after moving, I was instructed that it would be a good idea to join the local medical society as a good way to become involved in the medical community and meet other physicians. I still remember the warm reception we encountered when my wife and I showed up for our first Medical Society meeting. We were greeted by name and within a short period were introduced to many other new physicians that had recently moved to town, as well as many established physicians.

Since this first introduction, I have always enjoyed attending Medical Society meetings, socializing with other physicians, and enjoying a wonderful program. Often the programs are inspiring and thought provoking. At one of our recent meetings, I

was really struck by something not related to the program at all.

As can happen sometimes in medicine, I was having a bad week. I had a very hectic surgery schedule, many sick patients in the hospital and had to deliver bad news to some families relating to the poor prognosis of their loved ones. Apart from the busy clinical schedule, I had recently overheard conversations around the hospital of worsening reimbursement, shortage of doctors, and the ever-increasing demands on physicians.

Despite my busy week and pressures to get home at a reasonable hour to see my family, I decided to go to the Medical Society meeting on my way home to have dinner and relax. I can't recall the exact sequences of the night except that I arrived a little late and rushed in to go through the dinner line. When I had filled my plate, I looked around to find a place to sit and saw that most of the tables were either filled or empty except the one right in front of me that had several couples with one extra seat.

I politely introduced myself and asked if I could join them. I was greeted by several retired physicians and their wives, some of whose names were familiar as influential surgeons and medical doctors that had greatly contributed to the healthcare of our community.

As I sat down to eat, frustrated by what a bad week I was

having and lamenting my decision to become a doctor in these troubling times, I started listening to the dinner conversation.

Although the initial talk at the table was about their latest trips, upcoming activities, children and grandchildren, the conversation quickly changed to reminiscing about their lives as physicians and the wonderful experiences they had.

They told all kinds of stories about being a doctor and taking care of patients. As I listened, I slowly felt myself becoming less frustrated with my week and this profession I had chosen. I was sitting with a group of people who were proud of what they had accomplished and all the patients they had helped. More importantly, they had no regret on their decisions to become physicians and would have done it again in a heartbeat.

With all the impending pressures that we as physicians face, sometimes it is good to sit back and be reminded what a wonderful profession we belong to and how truly blessed we are to do what we do.

The next time you are having a bad day or week, just sit back and take a moment to remember what a wonderful opportunity we have to help our patients and their families and how fortunate we are to be in this profession.

We have experienced excellent and wellattended meetings, including visits example is tort reform. Without from AMA President Cecil Wilson and UNC Hall of Fame Basketball Coach Roy Williams, who gave not only one of the best talks we ever had, but gave it in front of an all-time record attendance for us. We were presented with a look back at the evolution of medicine in New Hanover County and were given projections for what the future of care might look like. We had a nice holiday wrap-up party during which the President-Elect of the NCMS, our own Mike Moulton. saved a man from choking at an event on the other side of the building. Our delegation to the NCMS sponsored 2 resolutions, both of which prompted action at the state level. Through it all, we have experienced tremendous physician engagement.

I believe that the grand successes of our year are a direct result of the degree of physician participation we have enjoyed. A prime the total engagement of so many of our colleagues throughout the legislative session, we would surely have been lamenting another lost opportunity rather than celebrating a long-overdue victory. For that participation, I would like to personally thank all who became involved. Because of you, it worked. For the first time in at least a decade, physician unity reached the "critical mass" necessary to forge the type alliances required for moving the political machine in the North Carolina Legislature, including a tightly contested veto override. This critical mass achievement is

remarkable, for it comes at a very uncertain time in the history of medicine for our country. Never before has the house of medicine faced the potentially tectonic shifts now in front of us. Yet, despite this lack of security, we, as physicians, have consolidated and done a good job of speaking with a single voice. From our success we might well take a lesson. No longer can we expect to achieve the needs of our practices by crying out as lone wolves in the dark, or by butting heads amongst ourselves. We must work to develop "good for medicine" positions that we can all support, and with this solidarity usher in new opportunity. It is we who must lead the charge into the future of health care delivery. It is we who have the best interests of the patient at the top of the priority list. It is we who must find ways to forge alliances heretofore believed to be unlikely, unnecessary, or impossible to achieve. In so doing we give ourselves the opportunity to continue to do what we love in a meaningful fashion and in a way over which we may exert some measure of control.

I look forward to working together with you as we shape our evolution.





- I. Where the departing physician will be practicing, including his new address and phone number.
- 2. How to access a copy of their records.

# I. Ecraseur (1870s)

This ecraseur was used to sever hemorrhoids and uterine or ovarian tumors. The chain was looped over the mass and tightened using the ratchet, stopping the circulation of blood to the area.

## 2. Artificial Leech (1800s)

Bloodletting with leeches was such a popular treatment for a range of medical conditions that an artificial leech was invented in 1840 and was used frequently in eye and ear surgery. The rotating blades would cut a wound in the patient's skin, while the cylinder would be used to produce a vacuum that sucked up the blood.

# 3. Hernia Tool (1850s)

This unique tool was used after the restoration of a hernia. It was inserted into the body near the affected area and left there for a week to produce scar tissue that would help seal off the hernia.
